### Discussion with your client

1. Please ensure the correct wording is used and include our full name: H and S Hoffman and G Korsunski Carmel School Inc and ABN: 957 45 747 731.
2. If your client would like the donation to be specific to a particular program at the School, or specific to a part of the School (for example, the Science Department, the Primary School Library etc), we will happily accommodate their wishes. If you need to discuss a specific request, please contact us at [shalom@carmel.wa.edu.au](mailto:shalom@carmel.wa.edu.au). Please note that donations to the Jewish Education Foundation, the Building Fund and the Library Fund are all tax deductible.
3. If your client would like to establish a legacy in recognition or memory of a loved one, we would encourage you to contact us to discuss the opportunity of titled buildings, educational experiences and programs or scholarships.

### Suggested wording for wills

### Administration of an estate

When it is time to administer an estate, Carmel School appreciates your assistance in the following ways:

1. Notify us – Please contact us on [shalom@carmel.wa.edu.au](mailto:shalom@carmel.wa.edu.au) and include a list of any gifts or assets that have been bequeathed to the School. Carmel School may request that certain assets be dealt with in a particular manner for tax purposes. For example, the School is exempt from payment of capital gains tax, and therefore an in specie transfer of CGT assets such as investment properties or shares (rather than a sale of those assets by the executors and a transfer of sale proceeds) may result in a significantly reduced tax liability.



2. Tell us about your client – we will always want to thank remaining family and friends, as well as honour your client's memory. Acknowledging your client in an authentic way will enable us to respect their final wishes as well as maximising the impact of the donation. In the event of a dispute regarding family provision it is the practice of Carmel School to attend mediation.
