

# Fees and Charges 2026



At Carmel School, we believe in transparency and value. Our tuition fees reflect the high-quality education and community experience we offer - integrating academic excellence with Jewish learning, wellbeing, and strong values. We thank our families for their ongoing partnership and support as together we continue to nurture confident, capable, and connected students.

## 1. Tuition Fees

Your child's annual tuition fee covers all curriculum costs, both secular and Jewish studies. Fees for 2026 are effective from **1 January 2026** and are reviewed annually by the School Board.

## 2. Family Discounts

We recognise the commitment of families with multiple children enrolled. Discounts apply to tuition only; levies are excluded.

- **Three children** attending the School - 10% discount
- **Four children** attending the School - 20% discount
- **Five children** attending the School - 30% discount

## 3. Additional Levies

To ensure a safe, modern, and enriching experience for every student:

- **Security Levy:** \$850 per family per year – Families completing 4 rostered duties receive a **\$100 credit**.
- **Technology Levy:** For students receiving new devices (in Years 5 & 8) \$698 per year (3-year program with insurance).
- **Camp Levy:** Jewish Studies (Zooz) Camps: \$130–\$190 depending on year level; Outdoor Education Camps: \$210–\$295
- **Shorashim (Year 10):** \$6,300 per student (refundable if the trip cannot proceed).
- **Music Tuition:** 20-minute lessons (Kindy–Year 3) are \$27, 30-minute lessons (Years 4–12) are \$40, and Instrument hire is \$210 per annum.

## 4. Payment Options and Methods

We offer flexibility for your family budget:

- **Annual (2% discount):** Pay in full by 28 February 2026
- **Termly:** Four equal instalments, due 14 days after term start
- **Monthly:** 11 instalments (15th of each month, February–December)
